





Executive Summary

The Indo Canada Chamber of Commerce's India Mission 2015 delegation to Ahmedabad, Gandhinagar, Jaipur and New Delhi from January 6 to 13, 2015, consisted of members from financial sector, small and medium businesses, hospitality, travel and tourism, information technology and real estate sector. Conclusions






