Indo-Canada Chamber of Commerce 2021 Awards

Nomination form for Male Professional of the Year

Before filling the Nomination Form, please ensure you have reviewed the submission guidelines and terms, and the category descriptions.

GUIDELINES FOR NOMINATION PROCESS.

Eligibility:

Male Professional of the Year Award recognizes the accomplishments and contributions of an Indo-Canadian¹ Male Professional (¹ Indo-Canadian is a person of Indian descent and who is at present a Canadian citizen or a landed immigrant) who meets the following eligibility criteria:

- Indo-Canadian Male Professional with a practice or service in a professional firm/ agency based in Canada.
- Minimum annual billing of \$1 million for self-employed; and\or consistent growth over the
 past five years in excess of annual revenues of \$1 million. (In case the nominee's profession
 relies on a different revenue parameter, the nominator will have to provide non-pecuniary
 evidence of excellence and high achievement in profession.)
- Nominee's practice/ institution has at least completed five years as of 01 April 2021.
- Nominee is responsible for day-to-day management of his area of practice, where he is an
 independent professional, or serving in a firm/ agency/ institution and is the chief/ key
 decision maker in the organization.
- Success in profession through:
 - a) Demonstration of leadership by using his abilities to develop or improve a program or service that significantly advances his profession
 - b) Demonstration of a commitment to life-long learning and expansion of his own personal and professional resources.
 - c) Demonstration of professional growth/ excellence by outstanding progress in his chosen career. For example:
 - I. Over time he has excelled by obtaining successively more responsible positions throughout his career
 - II. He has demonstrated innovation and creativity in his various positions to obtain a significant benefit for his employer or
 - III. He has consistently demonstrated exceptional job performance beyond what is normally performed or expected.
 - Tangible contribution to the Indo-Canadian community and the Canadian society.

Submission Guidelines:

Specific to this Award

Submission of proof:

Residency – either Permanent Resident Status or Canadian citizenship status.

- Gross Business Turnover \$1 million. This may be in the form of tax
- return filed with CRA or relevant abstracts of the company's financial statements
- clearly indicating the business revenues.
- Incorporation Certificate / Document of incorporation indicating the date of business registration to establish five years of existence, or five years of continued employment with the respective professional firm.
- Ownership & Managerial control Documents establishing nominee's operational and ownership control over the organization.
- Proof of achievement and all-round excellence in academics.
- Proof of impact: Tangible proof of impact of achievement on sector of specialization.
- Proof of service to the Indo-Canadian community the quality and quantity of service must be illustrated through examples.

General to all open categories:

- In any given year, a nominee may be nominated in one category only
- Previous recipients are not eligible to be re-nominated in the same category
- Nomination from previous two years will be considered along with current year's nominations, only if it is agreed to by the nominee and current and updated information is re-submitted
- The attached Nomination Form must be complete in all parts; with signatures of both the Nominator and the Nominee (forms without signatures are ineligible).
- Written submissions, including initial narrative and exhibits, should not exceed 50 pages.
- A detailed bio along with a summary of the background and history of the business, professional, and\or other activities must be included as attachments with the written submission.
- Provide specific and factual information, where possible with concrete examples of what was done, how it was done, what benefits, or results were realized.
- Supporting materials must be current and attached to or included with the form.
- While written submissions are allowed, electronic submissions are preferred (CD or USB stick; please do not send large data files via e-mail).
- Completed Forms should reach ICCC through e-mail (iccc@iccconline.org) on or before the submission date: 16 July 2021 by 5:00 PM.

Evaluation process:

- The Advisory Board of ICCC, an independent body of the Chamber, evaluates and selects the award recipient from the nominees.
- ICCC may engage an independent third-party to assist the Chamber and its advisory board to
 assist with the formal vetting and evaluation of nominations. You consent to the collection
 and use of your personal information by the Chamber and/ or its agent(s) for the purpose of
 assessing nominees' candidacy.
- The Advisory Board on behalf of ICCC may seek additional information from the nominator and / or the nominee during the evaluation process.

- Your nomination in no way obligates the Chamber to give the award to an eligible Nominee.
 The overall odds of winning the Award depend on the number and quality of nominations received.
- ICCC reserves the right to judge void any entry that the Chamber, in its sole and absolute
 discretion, determines do not meet these Terms and Conditions. Once submitted, you may
 not modify your Nomination Form.

Privacy:

By submitting a Nomination Form, you hereby consent to the Chamber collecting and using your personal information and to receiving commercial electronic messages from ICCC for the purpose of administering this Award.

Warranties, Representations and Licences:

All materials submitted become the property of the Chamber and will not be returned to the nominator and/ or the nominee. You hereby represent and warrant that the information you have provided in the Nomination Form is true, complete and correct to the best of your knowledge.

Announcement of Winners:

The Indo Canada Chamber of Commerce, at its sole discretion, will determine the Award winner per Nomination Category, from among the Eligible Nominees. The Chamber may, at its sole discretion, profile the confirmed winner in print, video, digital, electronic, mobile and social media formats of the Chamber. Winners will be announced and awarded at the Chamber's Annual Gala.
